The Kochi City Narcotic Cell on Tuesday arrested three youngsters with five grams of premium narcotic drug MDMA.

Encroachments along Vembanad Lake will be identified, says CM

Committee constituted to suggest remedial measures, Chief Minister tells Assembly

Revenue, Survey and Local Self-Government departments have initiated steps to identify and remove encroachments along the Vembanad Lake, according to Chief Minister Pinarayi Vijayan.

A committee was constituted on the recommendation of the Assembly Committee on Environment to examine encroachments and suggest remedial measures, he said in response to a submission by K. Babu, Thiruvananthapuram MLA, on Tuesday. The committee, which includes the District Collector as chairman and officials of various departments, has started work on identifying encroachments. The team will fix the boundary of the Vembanad Lake, which is a Ramsar wetland, as part of efforts to restore the ecosystem, he said.

The Chief Minister said the Ministry of Forest, Environment and Climate Change had categorised the Vembanad Lake as one of the critically vulnerable coastal areas in the country. It had also suggested the involvement of fisherfolk for ensuring sustainable use of resources and protection of the coastal region. The government will take necessary steps, including implementing the proposal to set up a Vembanad Lake authority, he said.

A study by the M.S. Swaminathan Foundation has found that the water holding capacity of the lake had declined considerably owing to the increased presence of silt and waste. A project has been formulated to construct an outer boundary around the 'R-block' paddy field using the removed mud and silt. It is likely to be implemented jointly by the government and the Padasakshara samiti in the public-private partnership mode.

Malappuram DCB-Kerala Bank merger: RBI nod expected

Cooperation Minister V.N. Vasavan has said the approval of the Reserve Bank of India (RBI) for the Malappuram District Cooperative Banks merger with the Kerala Bank is expected soon.

Speaking after tabling the Kerala Cooperative Societies (Second Amendment) Bill, 2022, in the Legislative Assembly on Tuesday, Mr. Vasavan said the RBI nod was bound to be expedited with the Kerala High Court vacating a stay that hindered the merger. As many as 769 branches that previously functioned under the 13 dis-

trict cooperative banks (DCB) except the one in Malappuram had already received the requisite RBI licence.

The Bill, which sought to extend the deadline for the merger by a year, was referred to the Subject Committee XI (on Food, Civil Supplies and Cooperation) following discussions.

M. Vincent (Congress) said Kerala Bank remained a disjoint group of banks and lacked a common framework three years after its formation. The government had also been unable to complete software integration in its branches across the State.

12-hour duty: unions, KSRTC management stick to their guns

It will throw entire system into disarray, says union leader

The Kerala State Road Transport Corporation (KSRTC) management says that there is no alternative but to introduce 12-hour duty for bus crew, since over 1,300 buses are idling for want of drivers, even as most trade unions have vehemently opposed this and termed it as impractical. "The sole alternative would be to wind up the RTC which has perennially been neck-deep in loss, and the State government had to pump in over 6,000 crore during the past six years to help it stay afloat," said a high-ranking official in the agency.

Reacting to Monday's talks with trade unions on introducing 12-hour duty ending in a stalemate, he said the Motor Transport Workers Act has capped 'hours of work' of bus crew at eight hours per day and 48 hours per week - meaning the total time when a driver is steering a bus. Bus crew will have

to work for only eight hours even if the 12-hour shift is introduced, while also getting 30 minutes rest after driving. The Act further permits extension of working hours to up to 12 hours, if needed. Thus, the main working hours will be 7 a.m. to 11 a.m. and 3 p.m. to 7 p.m., to cater to peak-hour demand, with a four-hour paid break in between, he said.

"The situation was warranted since there were insufficient crew members available for evening duty under the existing system, what with most of them opting for double duty or 16 hours of work. This resulted in some of them turning up for work for just two days a week and eight days a month."

"The net result was that more personnel had to be recruited, taking the bus-employee ratio to as high as 1.8-the highest in India. This in turn tremendously increased the salary and pen-

sion expenses of KSRTC."

Taking a different view, C.K. Hariharan, working president of Kerala State Road Transport Employees Association (CITU), said his union would not have opposed the move if duty time was curtailed to eight hours, as was the case till 1992. "Most crew have got accustomed to doing double duty during the past three decades. The extension of duty time to 12 hours could result in inadequate number of buses operating from 11 a.m. to 3 p.m., affecting commuters," he said.

The management seems to be in a hurry to reduce the number of personnel, said R. Aravappan, working president of Kerala State Road Transport Drivers Union. "It is not practicable and proper homework must be done. Both the management and workers will be at a loss if the 12-hour duty pattern is imposed, since it will throw the entire system into disarray," he said.

HC stays liquor shop closure in Vizhinjam

Court's observation
The court passed the stay order, pointing out that the protest against the Vizhinjam international seaport by the action council of fishers led by the Latin Archdiocese might not be violent, but it was continuing for long.

The Collector's order was challenged by a hotelier at Venganoor, Vizhinjam.

Directive
The petitioner sought a directive from the State government not to close down the bar hotel for two days within the limits of the Vizhinjam police in view of the agitation.

Motorcyclist's death: truck driver held

Nearly three weeks after the death of a motorcyclist on the national highway at Athani, which sparked off a raging controversy over the pitiable state of roads in the district, the Nedumbassery police on Tuesday took into custody a truck driver who had run over the victim.

Hashim, 52, of North Paravur, was run over by the truck, driven by Hanumanthappa, 28, of Karamana, after the former's motorcycle

reportedly hit a pothole following which he lost control of the vehicle and was thrown on the road on the night of August 5. Hanumanthappa had sped off following the incident. He was picked up from Karamana, and the truck was also taken into custody. The police could not track down the truck initially, since there were no CCTV cameras in the area. They had booked a case under IPC Section 304A (causing death by negligence) and had since then

launched a probe. The police said the truck, which is registered in Karnataka, was carrying chemicals to Bengaluru. They had reportedly tracked down the accused and the vehicle after checking the visuals from over 350 CCTV cameras along the route. The team also collected details of over 500 vehicle-owners as part of the investigation. The police are yet to record his arrest. They are grilling him on how the accident occurred and why he did not stop the vehicle.
