7.1.2. Management of the various types of degradable and non- degradable waste

• The college has an efficient waste management system to handle various types of waste. Our system operates on the principle of Reduce, Reuse and Recycle.

Management of solid waste

- The institution has signed an **MOU** with Green Evotech Pvt. Ltd. for the disposal of solid waste
- The segregation of biodegradable and non-biodegradable waste is carried out on site.
- For that, **separate**, **labelled waste bins** are provided for each classroom, lab, office, and corridor.
- The food waste generated in the college and hostel is used in biogas plant.

Biomedical waste management

• A separate, labelled bin has been set up for biomedical waste. This type of waste is disposed of through **incineration**.

Chemicals Waste

• Each waste generated in each lab is individually packed and sent to contractor for disposal.

E- waste

• The generation of e-waste is reduced through careful use and regular maintenance of electronic devices. Any E-waste generated will be sending to contractor for disposal.





3. Management of Chemical waste
